

## Milborne Port Cemetery Fees 2026 / 2027

The following fees apply where the person to be interred, or in respect for whom the right is granted, is, or immediately before death was, an inhabitant or parishioner of the Parish of Milborne Port, or, in the case of a still-born child, where the parents (or one of them) are, or at the time were, such inhabitants or parishioners. All fees are doubled for non-parishioners.

- All fees exclude the digging of the graves, for which the undertaker is responsible.
- The Parish Council will only deal with registered undertakers with reference to an interment of a body or cremated remains.
- The excess soil from a grave digging must be removed from site by the gravedigger.
- A charge of £500 will be made if all the soil from a grave digging is not removed from site at the time of interment.
- Headstones remain the responsibility / property of the purchaser, and they are expected to keep the headstone in good repair.
- Please note that the maximum size for a memorial on an ashes plot is 12" x 12", if larger memorial is required two plots should be purchased.
